Terms and Conditions of entry for the British Texel Sheep Society Tell Texel membership Questionnaire Free Prize Draw

1. The Win 50 Birth Notifications and £60 new Texel merchandise (the "Competition") is open to residents of the UK aged 18 and over.
2. Employees of Texel Sheep Society, or their family members, may not enter the Competition.
3. Entry into the Competition is acceptance of these Terms and Conditions.
4. Only one entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed. You are responsible for the cost (if any) of sending your Competition entry to us.
5. No responsibility is taken for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason.
6. The Competition closes at 12.00hrs 24th September 2018. Entries received after that date and time will not be considered.
7. The winner will be chosen from a random draw of entries.
8. One winner will receive 50 Birth Notifications for the flock they submitted the questionnaire for along with a £60 voucher for new Texel Sheep Society merchandise. There is no alternative prize and the prize cannot be redeemed for cash. The prize will be delivered to the winners home address as detailed on the survey form. Delivery is Free of Charge to GB Mainland and NI.
9. The winner will be notified on the 24th September 2018 and given details of how to claim their prize. If a winner does not respond to Texel Sheep Society within 7 days of being notified by Texel Sheep Society, then the winner's prize will be forfeited and Texel Sheep Society shall be entitled to select another winner (and that winner will have to respond to the Texel Sheep Society within 7 days or else they will also forfeit their prize).
