Terms and Conditions of entry for the Texel Society Free Prize Draw.

1. The Win 10-acre Forage Improvement Package or a 10-Acre Electric Fence Package competition (the "Competition") is open to residents of the UK aged 18 and over.

6. The Competition closes at 17.00hrs 31 October 2026. Entries received after that date and time will not be considered.
